

UŠĆE SHOPPING CENTER D.O.O. BEOGRAD, društvo sa ograničenom odgovornošću, sa sedištem u ul. Bulevar Mihajla Pupina 85B, Beograd, matični broj 20567716 (u daljem tekstu "**Društvo**"), u skladu sa Odlukom o osnivanju donetom dana 27. novembra 2015. godine kako je kasnije izmenjena, donosi sledeću:

ODLUKU O VANREDNOM RADNOM VREMENU I NERADNIM DANIMA

1. Imajući u vidu sezonu praznika, direktor Društva je odlučio da će tržni centar Ušće Shopping Center, koji se nalazi u ulici Bulevar Mihajla Pupina 4, Beograd, Srbija ("**Ušće Shopping Center**") i koji predstavlja osnovnu imovinu Društva, imati sledeće vanredno radno vreme:
 - na dan 31. decembar 2025. godine i 6. januar 2026. godine, radno vreme svih jedinica (lokali, kiosci, promo štandovi) u Ušće Shopping Center, izuzev bioskopa, će biti do 18:00h;
 - na dan 1. januar 2026. godine i 7. januar 2026. godine sve jedinice u Ušće Shopping Center, **neće raditi** zbog praznika, izuzev bioskopa koji će samostalno odrediti svoje radno vreme;
 - radno vreme parkinga će u svim gore navedenim slučajevima biti 30 minuta nakon isteka gore navedenih najkasnijih pojedinačnih radnih vremena odnosno nakon isteka rada bioskopa.
2. U svemu ostalom Odluka o radnom vremenu ostaje na snazi i primenjuje se tokom praznika.
3. Ovom Odlukom je određeno vanredno radno vreme Ušće Shopping Centra tokom praznika,

UŠĆE SHOPPING CENTER LTD BELGRADE, a limited liability company, with headquarters at Bulevar Mihajla Pupina 85B, Belgrade, having corporate identification number 20567716 (hereinafter: the "**Company**"), in accordance with its Memorandum of Association of the Company as of 27 November 2015, as amended thereafter enacts the following:

DECISION ON EXTRAORDINARY WORKING HOURS AND NON-WORKING DAYS

1. Having in mind the holiday season, the director of the Company decides that the shopping centre Ušće Shopping Center located in Bulevar Mihajla Pupina 4, Belgrade, Serbia ("**Ušće Shopping Center**"), which is the core property of the Company, will have the following extraordinary working hours:
 - on 31 December 2025 and 6 January 2026, the working hours of all business premises (units, kiosks, promo stand) in Ušće Shopping Center, except cinema, shall be until 18:00h;
 - on 1 January 2026 and 7 January 2026, all business premises in Ušće Shopping Center, shall be **closed** due to the holidays, except for the cinema which shall individually determine its own working hours;
 - the working hours of parking shall in each of the above cases be 30 minutes after the expiry of the above referred latest individual working hours, i.e., after the working hours of the cinema.
2. In all other aspects, the Decision on working hours remains applicable during the holidays.
3. This Decision stipulates the extraordinary working hours of Ušće Shopping Center,

pri čemu je svaki zakupac dužan da odredi svoje radno vreme, ali u okviru i u skladu sa gore navedenim radnim vremenom, vidno ga istakne i prijavi nadležnim organima u skladu sa pozitivnim propisima Republike Srbije.

4. Ova Odluka stupa na snagu danom donošenja i važi samo tokom perioda na koji se odnosi.
5. Ova Odluka ne zamenjuje Odluku o radnom vremenu od 24. maja 2018. godine.

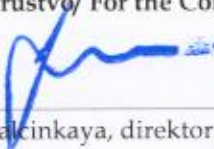
